Admission Procedures

There is no charge to apply to College of the Redwoods, and the application does not require you to register for classes; it just gives you the option.

All applicants are urged to complete the admission process as early as possible. You are considered a new student if you have not previously attended CR. You are considered a returning student if you have previously attended but have been away from CR for a semester or longer. If you have graduated from high school since you last attended CR, you need to complete a new application.

CR admits all high school graduates or the equivalent (GED, CA High School proficiency), and any person 18 years of age or over who is capable of benefiting from the instruction offered. If you are attending high school, additional documentation is required.

When are college transcripts required?

- If you plan to graduate from CR and you plan to use other college credits to fulfill your degree requirements
- If you have other college classes you wish to use to fulfill pre-requisites for courses at our college
- If you plan to apply for financial aid or veterans benefits
